Our Workforce Development Flagship Initiative

CareerConnect Martin started as a pilot project by leaders with the Stuart/Martin County Chamber of Commerce to bridge the gap between individuals and families struggling to earn a living wage and business owners also having difficulty connecting with motivated and trained professionals. As we watched participants dramatically increase earnings and become trusted members of the workforce, we were encouraged to form our 501(c)3 in 2023 to advance the mission.

Today, our career coaches help job seekers overcome barriers to full-time, meaningful employment through skill development, paid internships, and connections with local employers. This individualized support strengthens families and businesses at the same time.



We receive referrals from a large network of nonprofit and for-profit agencies, and we receive financial support from a growing list of funders.

Still, there is work to do. In Martin County, 44% of families live paycheck-to-paycheck. Our Foundation Board of Directors is focused on scaling the program to make an even bigger impact in our community.

Case Studies for CareerConnect Martin

Casey's Story: In 2022, Casey, a justice-impacted client, had a newborn baby, a huge heart, and a strong motivation to better her life. At the time, she completed Step-Up Services and a Trial Employment Opportunity with the local UPS store, where she was hired to work full-time. But when the store was sold in 2024, staffing changes left her unemployed. Again, she called her Career Coach Gina Masters.

"Situations happen," Gina said. "I was happy that she knew to come back here."

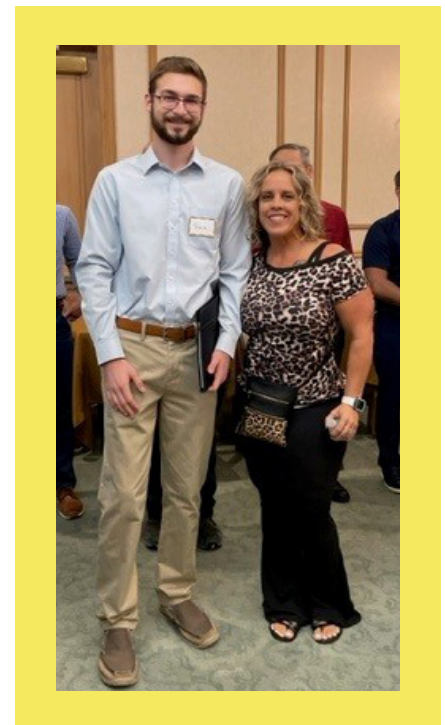
Casey matched with a new Trial Employment Opportunity with the local manufacturer Summit Collars, and she was hired again to work full-time. A single mother with a toddler, she now continues to have steady income, stay off state or federal unemployment, and do great work in a new industry.

Sam's Story: Born and raised in Martin County, Sam studied data analysis at Florida Gulf Coast University but wanted to return to live with his fiancée, Payge, in his hometown. To do that, both of them needed jobs.

"He first had to educate me about what data analysis was," Gina joked.

Sam completed his DISC assessment with Tim Kinane, and then Gina took him to a Chamber networking breakfast. She then reached out to her contacts with Waste Management, FPL, and the hospital to see if there were any openings for this kind of work. She forwarded his resume — and he was shortly hired as an SAP Financial Analyst for FPL earning a salary well above the median income here.

Meanwhile, Payge needed some help improving her resume. She had studied health sciences and was interested in working as a medical assistant, yet lacked those specific credentials. Payge completed the Step-Up Services and was hired by Water's Edge Dermatology. They agreed to pay for her training and certification while she worked. Now, the couple lives happily in Martin County.



Russell's Story: Russell, who had lived in Martin County for years, had a degree, veteran status, and a robust resume. But he was also recently released from incarceration. He was ready for a fresh start.

Gina and Russell worked on his resume, interview skills, and rebuilding his confidence. Then, he completed a DISC assessment with Career Coach Tim Kinane. With these new skills and connections, Russell was hired by the manufacturer Revolution Prototype and Machine (RPM).

He stopped in recently to share that he's been pre-approved for a mortgage and is smiling now more than ever.

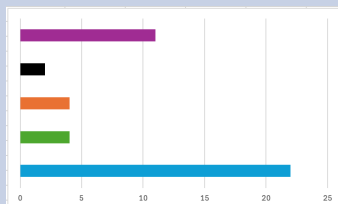

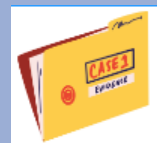

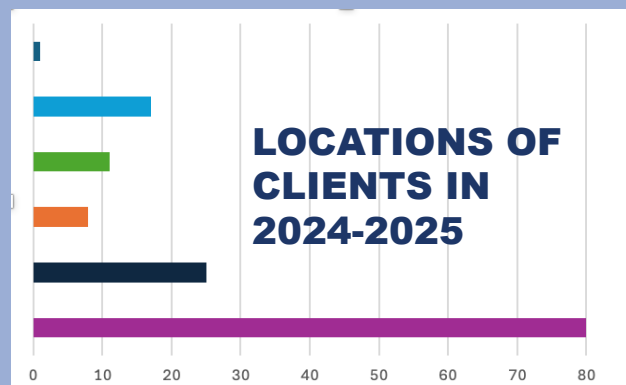

Entrepreneurship: Human Resource Support

The Martin Chamber Foundation seeks to be a resource for growth and efficiency for area business owners and professionals through human resource support initiatives. Along with in-person trainings and paid trainings for new employees through the CareerConnect Martin program, we also offer free and low-cost professional development e-courses for both hard and soft skills. From February 2024 until July 2025, area business representatives have completed **34 courses**. We encourage participating businesses to grow, as a rising tide lifts all boats!



Education: Joseph A. Catrambone Scholarship

Many high school graduates do not wish to pursue college or university studies as their post-secondary education, but that doesn't mean they can't be productive and important parts of the Martin County economy. In fact, trade professionals of all ages are the backbone of our community!

At the same time, area business owners have found a lack of properly trained and certified professionals in industries like marine mechanics, healthcare, manufacturing, logistics, and emergency personnel. This skills gap is being met through the Joseph A. Catrambone Scholarship fund.

This scholarship fund has awarded more than **\$42,000 to 15 Martin County students**, of all ages, for trade career certifications and training. These students, having gained a financial foundation in skills and knowledge, go on to become vital assets contributing to the success of local businesses and our entire community.

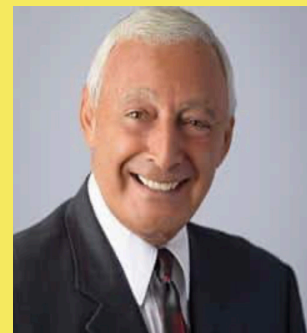
